The Visa Applicant is responsible for ensuring connection to a mobile network capable of receiving the SMS Services. The Visa Applicant understands that if The Visa Applicant 's mobile phone is switched off, disconnected for any reasons or is out of coverage for a period of 24 hours or more, The Visa Applicant's mobile network provider may delete any SMS messages to be received by The Visa
- 2. REGISTRATION WITH US EMBASSIES

The world unfortunately is not a safe place. When you travel abroad and surrounded by foreign environment many situations, in some cases hostile may arise, like terrorist attacks, banditry or even war. Plus there are natural disasters and catastrophes.

What is the registration?

Upon your request the Department of State in Washington DC will be provided with your major contact information in the country of your travel. U.S. consular officers assist Americans who encounter serious legal, medical, or financial difficulties.

- Itinerary. Copy of round trip tickets or confirmed itinerary. Hotel Reservations. Copy of confirmed hotel reservations.

- For employed applicants: An employment letter with the company letterhead and signed by a notary or with a dry stamp of the company.
 - For business owners: Commercial registration in original and in copy.

- A resident card or permanent visa and a copy (American tourist visas are not acceptable).
